

We are driven by our Mission Statement - Iowa County Humane Society Mission Statement:

The Iowa County Humane Society is a non-profit, tax exempt organization founded on the principle of maintaining a no-kill philosophy towards animal sheltering. We are dedicated to making our communities more humane places for all animals by: providing shelter and care to animals in need, helping our communities discover and nurture the human-animal bond through education, being a voice for those who have none through animal welfare advocacy and working towards a world where every animal has a loving home through progressive and innovative programs. We believe that all animals deserve a chance for a loving home for life.

We are committed to Iowa County –

- We moved to a larger facility, over doubling our square footage, at 305 County Rd YZ in the City of Dodgeville in January 2011 enabling ICHS to house more animals, create better quarantine space and do more outreach within the community by hosting community education events and dog training classes. This involved a significant investment to improve the building so that it could meet the needs of our animals and the community we serve. This investment was completely funded by donations. The added space means we are also in a better position to support the county’s Humane Officer, Public Health and Emergency Management needs (e.g. Animal Seizures or Avoca Floods).
- We purchased the building in April 2013 and in the past year have made a number of additional improvements; replacing furnaces, adding insulation, flooring, building play yards and outdoor kennels. These are meant to reduce operating costs and improve the animal’s welfare and enrichment. Again, all funded by the generosity of our donors. Additional improvements are planned when funds become available.
